ORDER APPROVING
TARIFF REVISIONS

On July 1, 2021, the South Dakota Public Utilities Commission (Commission) received a filing by Broadvox-CLEC, LLC (Broadvox) for approval of revisions to its Access Services Tariff No. 1. The purpose of this filing is to bring Broadvox's tariff into compliance with the Federal Communications Commission's (FCC) October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143. Broadvox requests an effective date of July 1, 2021.

On July 8, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of July 23, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On July 28, 2021, Broadvox filed a revised tariff page.
