On July 13, 2021, the South Dakota Public Utilities Commission (Commission) received a filing by Interstate Telecommunications Cooperative, Inc. fka SSTELECOM (Interstate) for approval of revisions to its Access Services Tariff. This filing proposes the first step in implementing the 8YY Access Service reductions mandated in the Federal Communications Commission's October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143.
