**ORDER APPROVING TARIFF

On July 27, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from Intrado Communications, LLC for approval of revisions to its Access Services Tariff. This filing proposes the first step in implementing the 8YY Access Service reductions mandated in the Federal Communications Commission's October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143. Intrado Communications, LLC requests an effective date of July 31, 2021.

On July 29, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of August 13, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received.
