On August 3, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from Neutral Tandem-South Dakota, LLC for approval of revisions to its Access Services Tariff. This filing proposes the first step in implementing the 8YY Access Service reductions mandated in the Federal Communications Commission's (FCC) October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143. Neutral Tandem-South Dakota, LLC requests an effective date of August 3, 2021.

On August 5, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of August 20, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. The requested effective date is August 3, 2021.
