On June 21, 2022, the South Dakota Public Utilities Commission (Commission) received a filing from Peerless Network of South Dakota, LLC (Peerless) for approval of revisions to its Access Service Tariff No 1. This filing proposes the second step in implementing the 8YY Access Service reductions mandated in the Federal Communications Commission's October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143.

On June 23, 2022, the Commission electronically transmitted notice of the filing and the intervention deadline of July 8, 2022, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No parties sought intervention. Peerless requests an effective date of July 1, 2022. On July 1, 2022, the company filed a corrected tariff page.

The Commission voted unanimously to approve the requested revisions to Peerless Network of South Dakota, LLC's Switched Access Service Tariff No. 1 with a July 1, 2022, effective date. It is therefore

ORDERED, that the above-referenced revisions to Peerless Network of South Dakota, LLC's Switched Access Service Tariff No. 1 are hereby approved, effective as of July 1, 2022.
