On June 27, 2022, the South Dakota Public Utilities Commission (Commission) received a filing from Granite Telecommunications, LLC (Granite) for approval of revisions to its Local Exchange Access Telecommunications Services Tariff No. 3. The purpose of this filing is to bring Granite's Local Exchange Access Telecommunications Services Tariff No. 3 into compliance with the Federal Communications Commission's October 9, 2020, Report and Order in WC Docket No. 18-156, FCC Release No. 20-143. Granite requested an effective date of July 1, 2022.

On June 30, 2022, the Commission electronically transmitted notice of the filing and the intervention deadline of July 15, 2022, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No parties sought intervention. On July 5, 2022, Granite filed revised tariff pages.
