RESOLUTION OF ANNEXATION


Comes now the City Council for the City of Beresford, Union and Lincoln Counties, South Dakota, and having received a Petition for Annexation of certain real property into the city limits and the Beresford City Council being satisfied that said property is contiguous to the municipality and having received a petition signed by 100% of the registered voters and by owners of 100% of the value of the territory sought to be annexed into the municipality;



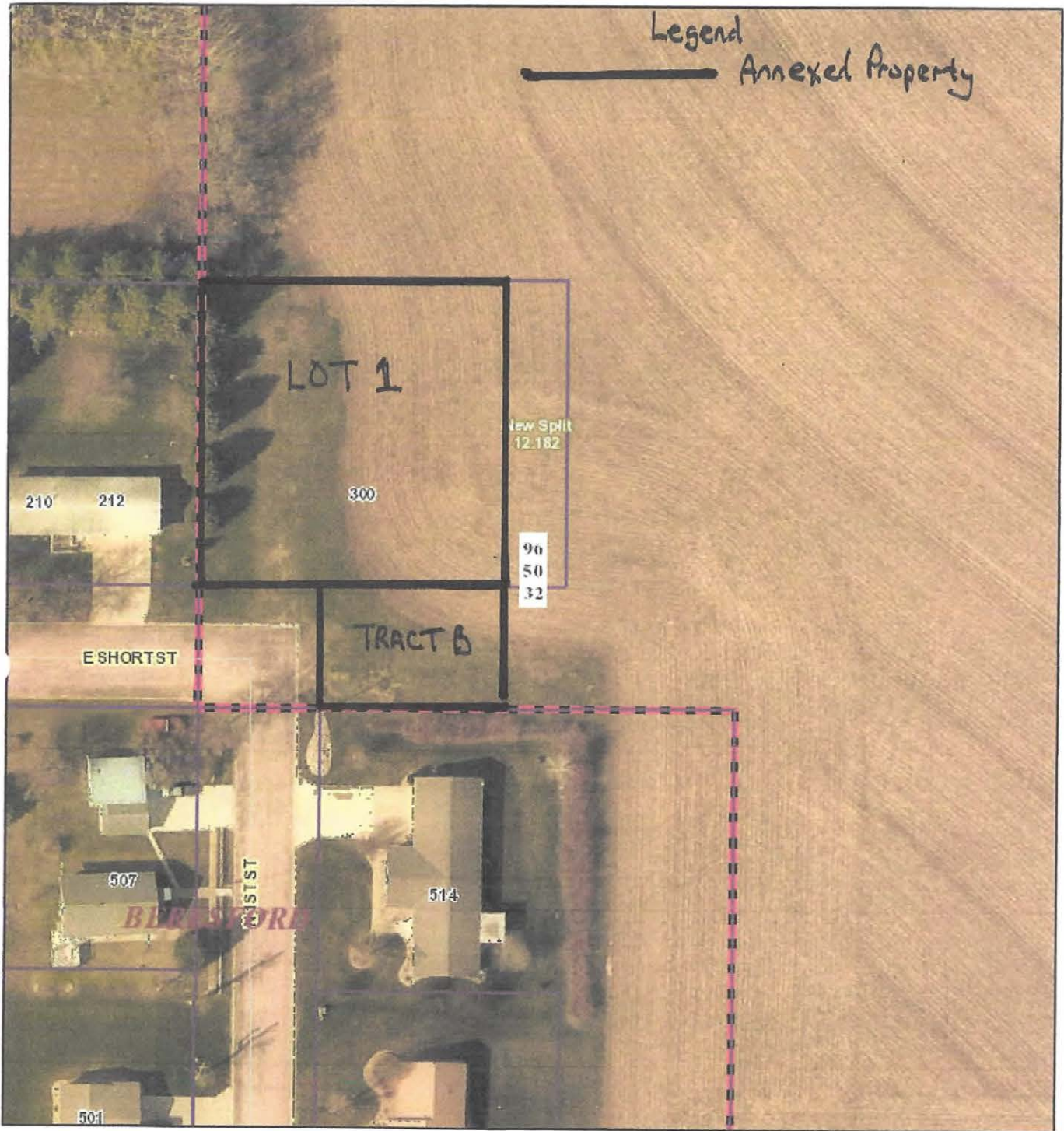

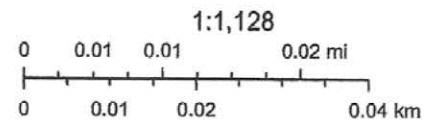
Lincoln County Property Map - Resolution 2017-5
