On October 27, 2022, the South Dakota Public Utilities Commission (Commission) received a filing pursuant to 47 U.S.C. § 252 for approval of the FCC Modernizing Unbundling and Resale Requirements Amendment to the Interconnection Agreement between Qwest Corporation dba CenturyLink QC (CenturyLink) and Consolidated Communications Enterprises Services, Inc. (fka Enventis Telecom Inc.). The amendment incorporates FCC Order 20-152 a Report and Order in WC Docket 19-308 for the Modernizing Unbundling and Resale Requirements in an Era of Next Generation Networks and Services, which were released by the Federal Communications Commission in 2020 and became effective February 8, 2021.

On November 3, 2022, the Commission electronically transmitted notice of the filing of the Amendment to the Interconnection Agreement to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. The notice stated that initial comments were due November 16, 2022. No comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and the Federal Telecommunications Act of 1996.

At its regularly scheduled meeting of November 18, 2022, the Commission considered whether to approve the negotiated Amendment to the Interconnection Agreement between Qwest Corporation dba CenturyLink QC and Consolidated Communications Enterprises Services, Inc. (fka Enventis Telecom Inc.). Commission staff recommended approval.

In accordance with 47 U.S.C § 252(e)(2), the Commission found that the Amendment to the Interconnection Agreement does not discriminate against a telecommunications carrier that is not a party to the Amendment to the Interconnection Agreement and the Amendment to the Interconnection Agreement is consistent with the public interest, convenience, and necessity. The Commission voted unanimously to approve the Amendment to the Interconnection Agreement. It is therefore

ORDERED, that the Commission hereby approves the Amendment to the Interconnection Agreement between Qwest Corporation dba CenturyLink QC and Consolidated Communications Enterprises Services, Inc. (fka Enventis Telecom Inc.).
