**ORDER APPROVING  
AMENDMENT TO  
INTERCONNECTION  
AGREEMENT**

On September 6, 2023, the South Dakota Public Utilities Commission (Commission) received a filing pursuant to 47 U.S.C. § 252 for approval of an SPOP in the LATA Amendment to the Interconnection Agreement (Amendment) between Qwest Corporation dba CenturyLink QC and SSTELECOM, INC. dba ITC for the State of South Dakota.

On September 7, 2023, the Commission electronically transmitted notice of the filing of the Agreement to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. The notice stated that any person wishing to comment on the parties' request had until September 25, 2023, to do so. No comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and the Federal Telecommunications Act of 1996.

At its October 10, 2023, meeting, the Commission considered whether to approve the Amendment to the Interconnection Agreement between CenturyLink and SSTELECOM, INC. dba ITC.

In accordance with 47 U.S.C § 252(e)(2), the Commission found that the Amendment does not discriminate against a telecommunications carrier that is not a party to the Interconnection Agreement and the Amendment is consistent with the public interest, convenience, and necessity. The Commission unanimously voted to approve the Amendment. It is therefore

ORDERED, that the Commission approves the SPOP in the LATA Amendment to the Interconnection Agreement between CenturyLink and SSTELECOM, INC. dba ITC.
