On August 15, 2023, the South Dakota Public Utilities Commission (Commission) received a filing Metropolitan Telecommunications of South Dakota, Inc. dba MetTel South Dakota (MetTel) for approval of revisions to its Access Services Tariff No. 3. The purpose of this filing is to revise all switched access rates to zero.

On August 17, 2023, the Commission electronically transmitted notice of the filing and the intervention deadline of September 1, 2023, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On August 17, 2023, MetTel filed revised tariff pages with an effective date of July 1, 2023.

At its regularly scheduled meeting of September 6, 2023, the Commission considered this matter. Commission staff recommended approval with an effective date of July 1, 2023. The Commission voted unanimously to approve the above-referenced revisions to MetTel's South Dakota Tariff Number 3, effective as of July 1, 2023. It is therefore

ORDERED, that the above-referenced revisions to MetTel's South Dakota Tariff Number 3 are hereby approved, effective as of July 1, 2023.
