On December 14, 2023, the South Dakota Public Utilities Commission (Commission) received a filing pursuant to 47 U.S.C. § 252 for the Amendment No. 2 to the Interconnection Agreement between Verizon Wireless and Golden West Telecommunications Cooperative, Inc. The Amendment authorizes Verizon Wireless' agent, Verizon Business, to order new direct connection facilities to the point of interconnection location within Golden West Telecommunications Cooperative's rate center.

On December 21, 2023, the Commission electronically transmitted notice of the filing of the Agreement to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. The notice stated that any person wishing to comment on the parties' request had until January 3, 2024, to do so. No comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and the Federal Telecommunications Act of 1996.

At its February 6, 2024, meeting, the Commission considered whether to approve the Amendment to the Interconnection Agreement between Verizon Wireless and Golden West Telecommunications Cooperative, Inc.

In accordance with 47 U.S.C § 252(e)(2), the Commission found that the Amendment does not discriminate against a telecommunications carrier that is not a party to the Interconnection Agreement and the Amendment is consistent with the public interest, convenience, and necessity. The Commission unanimously voted to approve the Amendment. It is therefore

ORDERED, that the Commission approves Amendment to the Interconnection Agreement between Verizon Wireless and Golden West Telecommunications Cooperative, Inc.
