(1) A description of the legal and organizational structure of the applicant's company:

THE PARENT COMPANY, BARR TELL USA BEGAN IN NEW YORK IN 1998 OFFERING A VARIETY OF TELECOMMUNICATION SERVICES TO BUSINESSES. IN THE BEGINNING THE COMPANY ACTED AS A RESELLER OR CAP (COMPETITIVE ACCESS PROVIDER) AND RESOLD PRODUCTS AND SERVICES PURCHASED FROM THIRD PARTY VENDORS. IT SOON BECAME PRACTICAL and LOGICAL TO FOCUS ON OBTAINING ITS OWN NUMBERING RESOURCES.

THE COMPANY THEN BEGAN A JOURNEY OF EXPANDING INTO OTHER STATES AS A FACILITIE'S BASED CARRIER AND/OR CLEC. THIS WAS LONG BEFORE VOIP AUTHORIZATIONS AS IPES CARRIERS WERE OFFERED BY THE FCC IN 2015.
