RESPONSE TO THIRD DATA REQUEST

3-1. Refer to Staff's Data Request 1-25 and TracFone's response. Since October 15, 2024, have TracFone or its various brands been investigated or penalized for any sort of waste, fraud, or abuse of the Lifeline program?

Response

No.

3-2. Would TracFone commit to notifying the SD PUC if TracFone ever becomes aware that it is under investigation, or has been penalized, for any sort of waste, fraud, or abuse of the Lifeline program?

Response

Verizon Value would commit to notifying the Commission if it has been penalized for waste, fraud, or abuse of the Lifeline program. However, Verizon Value would not agree to notifying the Commission about investigations regarding the Lifeline program. Investigations are often exploratory and confidential, and can remain pending for many years despite being dormant. Furthermore, the precise focus of investigations is often unknown and may never lead to an enforcement action. Verizon Value would be willing to notify the Commission if an investigation related to the Lifeline program leads to the issuance of a public document, such as a Consent Decree, Notice of Apparent Liability, or Forfeiture Order issued by the Federal Communications Commission. Notifying the Commission of those types of documents would provide the Commission with relevant information without requiring Verizon Value to disclose investigations that do not result in any finding of wrongdoing.
