#### Highway 385 construction on pause for Sturgis Rally

All construction activities on U.S. Highway 385 will be paused for the Sturglis Motorcycle Rally from Wednesday, July 31, through end-of-day on Monday, Aug. 12.

During that timeframe, all lanes will be open to traffic. The road surface from S.D. Highway 44 to Lake Pactola will be a type of sealed rock that resembles asphalt with lane markings painted ontoit. In addition to the road markings, there will be a temporary traffic signal at the intersection of Highway 365 and Highway 44.

There will be one and one-half mile north of Silver Gify Road and a 1,000-feet-long gravel diversion immediately south of the Pennington-Lawrence Courte line.
