On behalf of Zayo Network Services, LLC ("Applicant"), please find enclosed an Application in connection with the above-captioned matter, which is being submitted via e-filing.

Please note that **Confidential Exhibit E** to the Application has been redacted from the public version of the Application and is being electronically filed with the Commission under separate cover. Applicant hereby requests confidential treatment of **Confidential Exhibit E**, which consists of the financial statements of the Applicant's indirect parent, including its balance sheets, income statements, and cash flow statements for the year ending December 31, 2024 (the "Confidential Information"). Such financial information constitutes trade secrets or commercial information within the meaning of South Dakota Administrative Rules § 20:10:01:39(4) and South Dakota Codified Laws § 15-6-26(c)(7). Applicant requests that the Confidential Information being provided to the Commission continue to be treated as confidential before, during, and after the proceedings in the above-captioned matter.

The Confidential Information contains information that is commercially sensitive and is not available to the general public. Unrestricted availability of the details of the Confidential Information would provide competitors with information regarding the Applicant, which competitors could use to evaluate Applicant's business strategies to the Applicant's detriment. Such availability would disclose certain non-public details of the Applicant's
