**Re: Supplemental Response of Bluepeak to South Dakota Public Utilities Commission
Staff's First Set of Data Requests**

Dear Director Mohr,

On behalf of Clarity Telecom, LLC DBA as Bluepeak ("Bluepeak"), we provide this supplemental response to your staff's August 28, 2025 data request. This response provides additional information not available at the time of Bluepeak's initial response on September 26, 2025. Please do not hesitate to reach out with any further questions.

1-3. Provide the South Dakota tax numbers for Bluepeak BTS and Bluepeak ABS. If unavailable, when does the applicant estimate it will receive its South Dakota sales tax number? (Note that the application is not considered complete until this is received.)

The South Dakota tax license number for Bluepeak BTS Borrower, LLC ("Bluepeak BTS") is #1042-8811-ST.

The South Dakota tax license number for Bluepeak ABS Asset Entity I, LLC ("Bluepeak ABS") is #1042-8810-ST.

1-9. Provide a copy of the Bluepeak tariffs to be transferred to Bluepeak BTS.

For intrastate access service in Bluepeak's current ILEC territory, Bluepeak BTS will adopt Bluepeak's current tariff. Please see **Exhibit A** for a copy of the latest approved tariff.

For intrastate access service in the portions of Bluepeak's CLEC service territory other than the areas to be served by Bluepeak ABS, as described in Bluepeak's September 26 response to Request 1-5, Bluepeak BTS will adopt Bluepeak's current tariffs. Please see **Exhibit B** and **Exhibit C** for copies of the latest approved tariffs.

For interstate switched access service in Bluepeak's current ILEC territory, Bluepeak BTS will adopt the National Exchange Carrier Association, Inc.'s ("NECA") Tariff FCC No. 5 in place of Bluepeak. Please see **Exhibit D** for a copy of the latest approved tariff.

For interstate special access service in Bluepeak's current ILEC territory, Bluepeak BTS will adopt John Staurulakis, Inc. ("JSI") Tariff FCC No. 1 with Bluepeak's latest revisions. Please see **Exhibit E** for a copy of Bluepeak's latest approved revision.

For interstate access service in the portions of Bluepeak's CLEC service territory other than the areas to be served by Bluepeak ABS, as described in Bluepeak's September 26 response to Request 1-5, Bluepeak BTS will adopt Bluepeak's current tariff. Please see **Exhibit F** for the latest approved tariff.

1-10. Provide a copy of the proposed tariffs Bluepeak ABS intends to implement.

For intrastate access service in the portions of Bluepeak's CLEC service territory other than the areas to be served by Bluepeak BTS, as described in Bluepeak's September 26 response to Request 1-5, Bluepeak ABS will concur with the rates, terms, and conditions of Bluepeak's applicable current tariff, submitted as Exhibit C. Please see Exhibit G for Bluepeak ABS's proposed tariff, for which the rates, terms, and conditions are identical to Exhibit C.

For interstate access in the portions of Bluepeak's CLEC service territory other than the areas to be served by Bluepeak BTS, as described in Bluepeak's September 26 response to Request 1-5, Bluepeak ABS will concur with the rates, terms, and conditions of Bluepeak's current tariff, submitted as Exhibit F. Please see Exhibit H for Bluepeak ABS's proposed tariff, for which the rates, terms, and conditions are identical to Exhibit F.
