On February 16, 2005, the Public Utilities Commission (Commission) received a complaint filed by WWC License LLC (WWC) against Golden West Telecommunications Cooperative, Inc., Vivian Telephone Company, Sioux Valley Telephone Company, Union Telephone Company, Armour Independent Telephone Company, Bridgewater-Canistota Independent Telephone Company and Kadoka Telephone Company (Golden West Companies) regarding intercarrier billings.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including §§ 49-13-1 through 49-13-14.1, inclusive, and 49-31, including §§ 49-31-3, 49-31-15, 49-31-18, 49-31-19, 49-31-81, 49-31-89 and 49-31-109 through 49-31-114, inclusive, and 47 U.S.C. §§ 251 and 252.

The procedural history is set forth in the Notice of Hearing dated February 24, 2006. A hearing was held on this matter and was continued until August 7, 2006. Following the conclusion of the hearing on August 7, 2006, the parties agreed on an original briefing schedule.

Based upon the agreement and representations of counsel, it is

ORDERED, that the following briefing schedule shall be followed in lieu of the original briefing schedule set forth in Order Setting Briefing Schedule of August 24, 2006:

September 5, 2006	WWC's brief is due addressing WWC's complaint issues.
October 4, 2006	The Golden West Companies' and SDTA's briefs are due, addressing WWC's complaint issues, affirmative defenses to WWC's complaint, and the counterclaim issues.
October 17, 2006	Staff's brief is due.
October 26, 2006	WWC's brief is due, responding to counterclaim issues, and providing rebuttal on WWC's complaint issues.

November 9, 2006

The Golden West Companies' and SDTA's briefs are due, providing rebuttal on the counterclaim issues.
