On April 28, 2000, the Public Utilities Commission (Commission) received a complaint filed by Janette M. Ball, Sioux Falls, South Dakota (Complainant), against MCI WorldCom (MCI) regarding unauthorized switching of services.

On April 28, 2000, the complaint was faxed to MCI. Pursuant to ARSD 20:10:01:09, MCI was notified that it must satisfy the complaint or file an answer in writing with the Commission by May 19, 2000. On June 21, 2000, the Commission received an answer from MCI.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

By order dated August 10, 2000, a hearing was scheduled to be held in this docket, in conjunction with Docket CT00-084, on September 7, 2000, beginning at 8:30 A.M., in Room LCR1 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota. Commission Staff and the parties have requested a continuance of the hearing. It is therefore

ORDERED, that the hearing scheduled for September 7, 2000, is cancelled and a new hearing shall be set at a later time.
