On September 19, 2000, the Public Utilities Commission (Commission) received a complaint filed by Kathy Meyer, Selby, South Dakota (Complainant), against S&S Communications (S&S) regarding a disputed billing and charges for long distance services.

On September 19, 2000, the complaint was faxed to S&S. Pursuant to ARSD 20:10:01:09, S&S was notified that it must satisfy the complaint or file an answer in writing with the Commission by October 10, 2000. The Commission has not received an answer from S&S to this complaint. Commission Staff received word from the Complainant stating that the complaint against S&S had been resolved.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

On October 17, 2000, at a regularly scheduled meeting, the Commission considered this matter. Upon recommendation of Commission Staff, the Commission voted to dismiss the complaint and close the docket. It is therefore

ORDERED, that the complaint shall be dismissed and the docket closed.
