On July 27, 2000, the complaint was faxed to Starlink. Pursuant to ARSD 20:10:01:09, Starlink was notified that it must satisfy the complaint or file an answer in writing with the Commission by August 16, 2000. The Commission has not received an answer from Starlink to this complaint.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

By order dated October 30, 2000, a hearing was scheduled for December 12, 2000, beginning at 9:00 A.M., in Room 412 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota. Commission Staff has now been informed that settlement has been reached in this matter, so therefore the hearing is cancelled. It is therefore

ORDERED, that the hearing scheduled for December 12, 2000, is cancelled.
