On October 16, 2000, the Public Utilities Commission (Commission) received a complaint filed by Amy and Craig Johnson, Sioux Falls, South Dakota (Complainants), against MCI WorldCom (MCI) regarding unauthorized switching of services.

On October 16, 2000, the complaint was faxed to MCI. Pursuant to ARSD 20:10:01:09, MCI was notified that it must satisfy the complaint or file an answer in writing with the Commission by November 6, 2000. On October 27, 2000, the Commission received an answer from MCI.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive; and ARSD Chapters 20:10:01 and 20:10:34.

By order dated November 8, 2000, a hearing was scheduled for November 29, 2000, beginning at 1:30 P.M., in Room 412 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota. MCI has requested a continuance of the hearing. It is therefore

ORDERED, that the hearing scheduled for November 29, 2000, is cancelled and a new hearing shall be set at a later time.
