On December 30, 1999, the Public Utilities Commission (Commission) received a complaint filed by Earl and Pauline DeHoogh, Sioux Falls, South Dakota (Complainants), against OLS, Inc. (OLS) regarding switching telecommunications services through deceptive tactics. Complainants request that a large fine be assessed.

Pursuant to ARSD 20:10:01:08.01 and 20:10:01:09, if a complaint cannot be settled without formal action, the Commission shall determine if the complaint shows probable cause of an unlawful or unreasonable act, rate, practice or omission to go forward with the complaint.

On February 2, 2000, at a duly noticed meeting, Commission Staff recommended a finding of probable cause due to unresolved factual issues. The Commission voted unanimously to find probable cause.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.




By order dated March 14, 2000, a hearing was scheduled for May 2, 2000, in Room 412 of the State Capitol Building, 500 E. Capitol, Pierre, South Dakota, immediately following the hearing for Docket CT99-060, which is scheduled to begin at 1:00 o'clock P.M. On April 20, 2000, Commission Staff was contacted by Complainants who informed the Staff that settlement had been reached in this matter and they wished to have their complaint dismissed, so therefore the hearing is cancelled. It is therefore

ORDERED, that the hearing scheduled for May 2, 2000, is cancelled.
