On January 11, 2000, the Public Utilities Commission (Commission) received a complaint filed by Edward and Marvel Hinkelman, Watertown, South Dakota (Complainants), against OLS, Inc. (OLS) regarding switching telecommunications services through deceptive tactics. Complainants request that OLS stop misrepresenting itself and remove all charges.

Pursuant to ARSD 20:10:01:08.01 and 20:10:01:09, if a complaint cannot be settled without formal action, the Commission shall determine if the complaint shows probable cause of an unlawful or unreasonable act, rate, practice or omission to go forward with the complaint.

On February 2, 2000, at a duly noticed meeting, Commission Staff recommended a finding of probable cause due to unresolved factual issues. The Commission unanimously voted to find that there was probable cause of an unlawful or unreasonable act, rate, practice, or omission on the part of OLS. On May 9, 2000, the Commission Staff received word from Complainants indicating that there had been a resolution of the matter and that the case should be considered closed.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7, 49-31-7, 49-31-7, 49-31-7, 49-31-7, 49-31-7, 49-31-38, 4

On May 30, 2000, at a regularly scheduled meeting, the Commission considered this matter. Upon recommendation of Commission Staff, the Commission voted to dismiss the complaint and close the docket. It is therefore

ORDERED, that the complaint shall be dismissed and the docket closed.
