On November 29, 2000, the Public Utilities Commission (Commission) received a complaint filed by Gerald and Evelyn Holdhusen, Aberdeen, South Dakota (Complainants), against Talk.com Holding Corp. d/b/a The Phone Company (Talk.com) regarding unauthorized switching of services.

On November 29, 2000, the complaint was faxed to Talk.com. Pursuant to ARSD 20:10:01:09, Talk.com was notified that it must satisfy the complaint or file an answer in writing with the Commission by December 19, 2000. The Commission has not received an answer from Talk.com to this complaint.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

By order dated December 20, 2000, a hearing was scheduled for January 17, 2001, in the Commission's Cactus Conference Room, State Capitol Building, 500 E. Capitol, Pierre, South Dakota. On January 5, 2001, Commission Staff received a settlement and release of the complaint, so therefore the hearing is cancelled. It is therefore

ORDERED, that the hearing scheduled for January 17, 2001, is cancelled.
