On August 6, 2001, the Public Utilities Commission (Commission) received a complaint filed by Gerald Larson, Beresford, South Dakota (Complainant), against Beresford Municipal Telephone Company (Beresford), AT&T Communications of the Midwest, Inc. (AT&T) and T-NETIX Telecommunications Services, Inc. (T-NETIX) regarding unauthorized collect call charges.

On August 7, 2001, the complaint was faxed to Beresford, AT&T and T-NETIX. Pursuant to ARSD 20:10:01:09, Beresford, AT&T and T-NETIX were notified that they must satisfy the complaint or file answers in writing with the Commission by August 27, 2001. On August 14, 2001, AT&T filed a Motion to Dismiss AT&T as a Party to this Proceeding. On August 27, 2001, Beresford filed an Answer and Motion to Dismiss of Beresford Municipal Telephone Company. The Commission has not received answers from AT&T or T-NETIX to this complaint.

On September 7, 2001, at a duly noticed meeting, Commission Staff recommended that the Commission grant AT&T's Motion to Dismiss and deny Beresford's Motion to Dismiss.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26, 49-13, including 49-13-1 through 49-13-14, inclusive, and SDCL Chapter 49-31, including 49-31-3, 49-31-7, 49-31-7.1, 49-31-7.2, 49-31-7.3, 49-31-7.4, 49-31-10, 49-31-11, 49-31-38, 49-31-38.1, 49-31-38.2, 49-31-38.3, 49-31-89 through 49-31-97, inclusive, and ARSD Chapters 20:10:01 and 20:10:34.

On September 7, 2001, at a regularly scheduled meeting, the Commission considered this matter. The Commission voted to grant AT&T's Motion to Dismiss and deny Beresford's Motion to Dismiss. It is therefore

ORDERED, that AT&T's Motion to Dismiss is granted and Beresford's Motion to Dismiss is denied.
