# BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF SOUTH DAKOTA

On December 10, 1997, the South Dakota Public Utilities Commission (Commission) received a complaint from Angelia Qualls, 125 S. Conklin #5, Sioux Falls, South Dakota (Complainant) against Northern States Power Company (NSP) regarding unpaid balances on her account. In the complaint, Complainant states that her name was added to utility bills by a person with whom she was cohabitating, that the name used was not her actual name, that certain arrearages have occurred in the account and that NSP is now trying to collect these arrearages from her. Complainant has requested the Commission to determine the merits of her complaint and that NSP not disconnect the electric service until such time as the complaint is resolved.

Pursuant to ARSD 20:10:01:08.01 and 20:10:01:09, if a complaint cannot be settled without formal action, the Commission shall determine if the complaint shows probable cause of an unlawful or unreasonable act, rate, practice or omission to go forward with the complaint.

On December 18, 1997, a regularly scheduled meeting, the Commission considered the matter along with comments from Complainant and NSP.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A and ARSD 20:10:01:08.01 and 20:10:01:09. The Commission voted to find probable cause (Commissioner Schoenfelder, dissenting). It is therefore

**ORDERED**, that probable cause has been found in this matter and that the complaint shall be forwarded to NSP and NSP shall file with the Commission its answer in writing within twenty (20) days of service of this order.
