On April 16, 2012, Black Hills Power, Inc. (BHP) filed an Application for Environmental Improvement Adjustment with the Public Utilities Commission (Commission). The Application requests Commission approval of its revised Environmental Improvement Adjustment (EIA) in accordance with BHP's tariff provisions approved in Docket EL11-001. The Application provides the second year revenue requirement and customer rates for the environmental improvements made to the Wyodak Power Plant, along with the project cost true-up and an annual true-up. BHP requests a June 1, 2012, effective date. On April 19, 2012, the Commission electronically transmitted notice of the filing and the intervention deadline of May 1, 2012, to interested individuals and entities. No petitions for intervention were filed. On May 10, 2012, the Commission issued its Order Assessing Filing Fee assessing a fee up to the statutory limit of \$50,000. On May 11, 2012, BHP filed revised exhibits and tariff sheets and its jurisdictional report of earnings. On May 11, 2012, the Commission's staff (Staff) filed a Memorandum recommending approval of the 2012 EIA and the associated tariffs as filed on May 11, 2012.

The Commission found and concluded that the revised exhibits and tariff sheets meet the standards for approval set forth in SDCL 49-34A-98 and voted unanimously to approve the revised 2012 EIA.

It is therefore

ORDERED, that BHP's 2012 EIA, including the above referenced tariff sheets, is hereby approved, effective on and after June 1, 2012.
