**ORDER APPROVING 2017  
TRANSMISSION COST  
RECOVERY ELIGIBILITY AND  
RATE ADJUSTMENT**

**EL16-035**

On November 1, 2016, the South Dakota Public Utilities Commission (Commission) received a Petition for Annual Update to Transmission Cost Recovery (TCR) Rider Rate from Otter Tail Power Company (Otter Tail). The update includes the tracker balance estimated for the end of the current recovery period so that no over- or under-recovery of TCR costs occurs. The update also includes the addition of one new transmission project that is not currently in base rates and has not previously been approved for inclusion in the TCR Rider. Otter Tail's petition proposed a March 1, 2017, effective date.

The revised tariff sheet effective for service rendered on and after March 1, 2017, is as follows:

On November 3, 2016, the Commission electronically transmitted notice of the filing and the intervention deadline of November 18, 2016, to interested persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On November 28, 2016, the Commission issued an Order Assessing Filing Fee. On January 20, 2017, Otter Tail filed a Supplemental Filing with revised Attachments 1 through 24. On January 26, 2017, Commission staff (Staff) filed its Staff Memorandum.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-25.1 through 49-34A-25.4.

At its regularly scheduled meeting on February 10, 2017, the Commission considered this matter. Having thoroughly reviewed the filings in the docket and made further inquiry of the parties at the meeting, the Commission voted unanimously to approve the TCR revenue requirement and rates recommended by Staff with an effective date of March 1, 2017. It is therefore

ORDERED, that the TCR revenue requirement and rates recommended by Staff are approved. It is further

ORDERED, that the above-referenced tariff sheet is approved with an effective date of March 1, 2017.
