**ORDER APPROVING
TARIFF REVISIONS**

On October 19, 2017, the South Dakota Public Utilities Commission (Commission) received a filing from Montana-Dakota Utilities Co. (MDU) for approval of tariff revisions for rate 95 (occasional power purchase non-time differentiated) and Rate 96 (short-term power purchase). This filing updates the energy and capacity payments. MDU states it currently has only one customer taking service under these rates and the annual change in revenue due to this filing will be minimal. A January 1, 2018, effective date is requested.

On October 26, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of November 13, 2017, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On November 21, 2017, MDU filed its responses to staff's data request.

The Commission has jurisdiction over this matter pursuant to 16 U.S.C. Chapter 12, § 824a-3, 18 C.F.R. Part 292, SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, and 49-34A-93, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on December 19, 2017, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a January 1, 2018, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective January 1, 2018. It is therefore

ORDERED, that MDU's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective for services rendered on and after January 1, 2018.
