**ORDER ASSESSING
FILING FEE; AUTHORIZING
EXECUTIVE DIRECTOR TO ENTER
INTO A CONSULTING CONTRACT**

On December 15, 2017, the South Dakota Public Utilities Commission (Commission) received an application from Crocker Wind Farm LLC (Crocker) for a wind energy facility and transmission facility permit a 345 kV Transmission Line (Projects) to construct the Crocker Wind Farm, a wind energy facility located on approximately 29,331 acres of privately owned land in Clark County, South Dakota, approximately 8 miles north of Clark, South Dakota. The proposed projects include up to 120 wind turbines, associated access roads, a new collector substation, an operations and maintenance facility, and associated 345 kilovolt (kV) transmission in Clark County, South Dakota. The projects will result in the installation of approximately 5.2 miles of overhead transmission that will be wholly located within the Wind Farm's boundary. The Transmission Line Route will run from a substation in Section 30 of Township 119N, Range 58W to the Point-of-Interconnect (POI), which is located approximately 2 miles north of the town of Crocker in Section 9 of Township 119N, Range 58W. Two routing options from the substation in Section 30 are under consideration. At the POI, the power will transfer to the Basin Electric Groton-to-Watertown 345 kV transmission line, part of the Southwest Power Pool, Inc./Western Area Power Administration Transmission line portfolio in Clark County, South Dakota.

SDCL 49-41B-12 authorizes the Commission to assess a maximum fee not to exceed one-quarter of one percent for the first one hundred million dollars of estimated construction costs of the Project plus one-twentieth of one percent of all additional estimated construction costs of the Project. However, the minimum total fee chargeable may not be less than eight thousand dollars. The fee shall be deposited in a subfund in the Commission's Regulatory Assessment Fee Fund to defray Commission expenses incident to analyzing and ruling upon the Application.

At its regularly scheduled meeting on January 3, 2018, the Commission considered this matter. Commission Staff requested that the Commission assess a filing fee not to exceed \$500,000 with an initial deposit of \$8,000 and to authorize the Executive Director to enter into consulting contracts needed for review of the Application. Crocker stated it did not object to the fee assessment. The Commission voted unanimously to assess Crocker a filing fee in an amount not to exceed \$500,000, with a minimum filing fee of \$8,000 to account for actual expenses incurred in review of the wind energy facility portion of this filing commencing from the filing date. The Commission further voted unanimously to authorize the Executive Director to enter into necessary consulting contracts. It is therefore

ORDERED, that Crocker shall be assessed a filing fee not to exceed \$500,000 for the wind energy facility portion of the Application. It is further

ORDERED, that Crocker shall make an initial deposit with the Commission in the amount of the minimum filing fee of \$8,000 and shall from time to time make such additional deposits up to the total amount of the assessment as requested by the Commission's Finance Manager. It is further

ORDERED, that the Executive Director is authorized to enter into necessary consulting contracts.
