On March 1, 2018, the South Dakota Public Utilities Commission (Commission) received a petition from Montana-Dakota Utilities Co. (MDU) for approval of the annual update to its Infrastructure Rider Rate (IRR), pursuant to the terms of the company's IRR 56 tariff. MDU is proposing to decrease the tariff rate to \$0.00432 per kWh for the rate period covered by this filing. Under the IRR 56 tariff, MDU shall update the Infrastructure Rider annually to be effective each May 1.

On March 8, 2018, the Commission electronically transmitted notice of the filing and the intervention deadline of March 23, 2018, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. The revised tariff sheet effective for service rendered on and after May 1, 2018 is as follows:

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, and 49-34A-12, 49-34A-73 through 49-34A-78.

At its regularly scheduled meeting on April 20, 2018, the Commission considered this matter. Commission staff recommended the Commission approve MDU's request to decrease the existing tariff rate to \$0.00432 per kWh. Finding the request to be just and reasonable, the Commission voted unanimously to approve MDU's request. It is therefore

**ORDERED**, that the Infrastructure Rider Rate of \$0.00432 and updated tariff sheet set forth above are approved effective May 1, 2018.
