**ORDER ASSESSING
FILING FEE**

On March 1, 2018, the South Dakota Public Utilities Commission (Commission) received a filing from Montana-Dakota Utilities Co. (MDU) for approval of its annual update to its Transmission Cost Recovery (TCR) Rider. MDU's TCR rate has been adjusted to reflect the projected charges for 2018 assessed to MDU for transmission service provided by the Midcontinent Independent System Operator and Southwest Power Pool, along with projected revenues and/or credits received by MDU for transmission related services. MDU proposes a TCR rate of \$0.00545 per kWh effective May 1, 2018. The proposed TCR rate of \$0.00545 per Kwh is applicable to all electric retail rate schedules and reflects an increase of \$0.00107 per Kwh from that currently authorized.

On March 8, 2018, the Commission electronically transmitted notice of the filing and the intervention deadline of March 23, 2018, to interested persons and entities on the Commission's PUC Weekly Filings electronic listserv.

The Commission has jurisdiction in this matter pursuant to SDCL 49-1A-8 and 49-34A-25.1 through 49-34A-25.4.

SDCL 49-1A-8 authorizes the Commission to require a deposit of up to \$50,000 in the Commission's Regulatory Assessment Fee Fund to defray Commission expenses incident to analyzing and ruling upon this type of filing.

At its regularly scheduled meeting on March 20, 2018, the Commission considered this matter. The Commission voted unanimously to assess a filing fee as requested by Commission staff up to the statutory limit of \$50,000 to account for actual expenses incurred in review of this filing commencing from the filing date. It is therefore

ORDERED, that MDU shall be assessed a filing fee pursuant to SDCL 49-1A-8 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$50,000.
