On December 6, 2018, the Commission electronically transmitted notice of the filing and the intervention deadline of December 21, 2018, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On December 12, 2018, Xcel filed revised tariff pages.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-10, and ARSD Chapter 20:10:13.

At its regularly scheduled meeting on January 18, 2019, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a January 22, 2019, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective January 22, 2019.

It is therefore

ORDERED, that Xcel's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective for services rendered on and after January 22, 2019.
