**ORDER GRANTING  
APPROVAL OF ELECTRIC  
SERVICE TERRITORY  
BOUNDARY AGREEMENT**

On December 5, 2018, the South Dakota Public Utilities Commission (Commission) received a filing from the Commission's staff (Staff) regarding an Electric Service Territory Boundary Agreement between Central Electric Cooperative, Inc. and NorthWestern Corporation dba NorthWestern Energy. Staff filed a revision to the legal description and revisions to the map on December 10, 2018. This filing is made pursuant to current efforts of the PUC to verify electric territory mapping data for conversion to electronic format and use in a Geographic Information System (GIS) database. With the assistance of the above-referenced utilities, staff has confirmed the service territory boundary shared by these utilities and has prepared updated mapping information. Staff asks for approval of the agreement to update official mapping data to properly reflect the service territory boundaries shared by the utilities in this docket.

On December 6, 2018, the Commission electronically transmitted notice of the filing and the intervention deadline of December 21, 2018, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A, specifically, 49-34A-42, 49-34A-43, and 49-34A-55.

At its regularly scheduled meeting on December 28, 2018, the Commission considered this matter. Staff requested approval of the Agreement in order to update the official electric service territory mapping data to accurately reflect the current service territories served by the utilities. The Commission voted unanimously to approve the Agreement. It is therefore

**ORDERED**, that the request for approval of the Agreement to update the mapping data to reflect the current electric service territory boundaries between the Central Electric Cooperative, Inc. and NorthWestern Corporation dba NorthWestern Energy is hereby granted.
