ORDER APPROVING TARIFF REVISIONS

On February 1, 2019, the South Dakota Public Utilities Commission (Commission) received a filing from Otter Tail Power Company (Otter Tail). This filing proposes updates to Otter Tail's Small Power Producer Riders, Sections 12.01, 12.02, and 12.03 in Otter Tail's tariff book. In the listed sections, Otter Tail proposes to update the energy and capacity payments as well as the wind and solar renewable energy credit values. These payments are made to qualifying facilities within the Otter Tail service area. Otter Tail requests an effective date of April 1, 2019.

The Commission has jurisdiction over this matter pursuant to 16 U.S.C Chapter 12, § 824a-3, 18 C.F.R. Part 292, SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, 49-34A-93, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on March 1, 2019, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an April 1, 2019, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective April 1, 2019.

It is therefore

ORDERED, that Otter Tail Power's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective for services rendered on and after April 1, 2019.
