ORDER GRANTING
APPROVAL OF ELECTRIC
SERVICE TERRITORY
BOUNDARY AGREEMENT

On May 1, 2019, the South Dakota Public Utilities Commission (Commission) received a filing from the Commission's staff (Staff) regarding an Electric Service Territory Boundary Agreement (Agreement) between Southeastern Electric Cooperative, Inc. (Southeastern) and Northern States Power Company dba Xcel Energy (Xcel). This filing was made pursuant to current efforts of the Commission to verify electric territory mapping data for conversion to electronic format and use in a Geographic Information System (GIS) database. With the assistance of the above-referenced utilities, Staff has confirmed the service territory boundary shared by these utilities and has prepared updated mapping information. Staff requested approval of the Agreement to update the official mapping data to properly reflect the service territory boundaries shared by the utilities in this docket.

On May 2, 2019, the Commission electronically transmitted notice of the filing and the intervention deadline of May 17, 2019, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. The matter was deferred at the May 28, 2019, Commission meeting. On May 30, 2019, Staff filed an unsigned Agreement, a revised legal description, and associated maps. On June 4, 2019, Staff filed the executed Agreement.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A, specifically, 49-34A-42, 49-34A-43, and 49-34A-55.

At its regularly scheduled meeting on June 11, 2019, the Commission considered this matter. Staff requested approval of the Agreement in order to update the official electric service territory mapping data to accurately reflect the current service territories served by the utilities. The Commission voted unanimously to approve the Agreement. It is therefore

ORDERED, that the request for approval of the Agreement to update the mapping data to reflect the current electric service territory boundaries shared by Southeastern and Xcel is hereby granted.
