On May 1, 2019, the South Dakota Public Utilities Commission (Commission) received an application from Black Hills Power, Inc. dba Black Hills Energy (BHE) for approval of an adjustment to Its Cogeneration and Small Power Production Service Simultaneous Net Billing Generation Credit Rate(s). BHE requests to change its generation credit rate found on Section No. 3B, Sheet No. 9 and to cancel Sheets No. 1 through 8. BHE requests to change from a single generation credit rate to a solar and wind seasonal on- and off-peak generation credit rate. An effective date of June 1, 2019 was requested in the application. On July 11, 2019, BHE filed a letter regarding revised exhibits, stating it no longer requests separate on- and off-peak rates due to complications for implementing the rates for customers on the Residential Demand Rate, and instead requests approval to change its existing generation credit rate to \$0.0248 per kWh, effective August 1, 2019.

On May 2, 2019, the Commission electronically transmitted notice of the filing and the intervention deadline of May 17, 2019, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to 16 U.S.C Chapter 12, § 824a-3, 18 C.F.R. Part 292, SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, and 49-34A-93, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on July 25, 2019, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an August 1, 2019, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective August 1, 2019. It is therefore ORDERED, that BHE's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective for services rendered on and after August 1, 2019.
