On January 7, 2020, the South Dakota Public Utilities Commission (Commission) received a joint request from Black Hills Electric Cooperative, Inc. (BHEC) and Black Hills Power, Inc. dba Black Hills Energy (BHE) seeking to modify existing service territory boundaries in Sections 28, 33, and 34 of Township 1 South, Range 5 East, Pennington County, South Dakota.

On January 16, 2020, the Commission electronically transmitted notice of the filing and the intervention deadline of January 24, 2020, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On January 27, 2020, Commission staff filed an Addendum, signed by both companies, agreeing to amend the existing electric service territory boundary agreement from EL19-001 (Amended Agreement). At the February 18, 2020, Commission meeting the matter was deferred. On February 27, 2020, a revised Exhibit C and a revised Exhibit D were filed into the docket.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A, specifically, 49-34A-42, 49-34A-43, and 49-34A-55.

At its regularly scheduled meeting on March 6, 2020, the Commission considered this matter. Commission staff recommended approval of the Amended Agreement in order to update the official electric service territory mapping data to accurately reflect current service territories served by BHEC and BHE. The Commission voted unanimously to approve the Amended Agreement. It is therefore

ORDERED, that the request for approval of the Amended Agreement to update the mapping data to reflect the current electric service territory boundaries shared by BHEC and BHE is hereby granted.
