On January 31, 2020, the South Dakota Public Utilities Commission (Commission) received a filing from Otter Tail Power Company (Otter Tail) for approval of tariff revisions to its Small Power Producer Riders, Sections 12.01, 12.02, and 12.03. Otter Tail proposes to update the energy and capacity payments as well as the renewable energy credits. These payments are made to small qualifying facilities within the Otter Tail service area. Otter Tail requests an effective date of April 1, 2020.

At its regularly scheduled meeting on March 17, 2020, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an April 1, 2020, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective April 1, 2020. It is therefore

ORDERED, that Otter Tail Power's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective for services rendered on or after April 1, 2020.
