

ORDER AUTHORIZING
LIQUIDATION OF
GRAIN INVENTORY

The above Court having received the Motion of the Receiver to Liquidate Inventory, having conducted a hearing on the 24th day of April, 2001, and having heard and considered the arguments of the responding parties hereby ORDERS that the Receiver in this matter shall:

1. Liquidate the grain inventory of Freeman Fertilizer Co., Inc. d/b/a McCook Feed & Fertilizer currently in its possession;
2. Solicit bids for a sale of the inventory both directly and through publication in the Salem, Canistota and Freeman newspapers.
3. Receive bids on the corn, soybeans and oats separately.
4. Consider all bids in a manner which it considers to be in the best interest of all potential claimants.
5. Sell the inventory to those bids it reasonably deems most beneficial to the potential claimants as a whole **only upon final approval of this Court.**
6. Place the proceeds from the sale of the inventory in a bank in Pierre, South Dakota, in an account that is both interest bearing and FDIC insured.
