On June 9, 2010, the Commission received an application by NorthWestern Corporation dba NorthWestern Energy (NorthWestern) for approval of a contract with deviation with less than 30 days notice to construct a natural gas line to serve the South Dakota Wheat Growers Facility in Andover, South Dakota. NorthWestern will install, or arrange for the installation of, approximately five miles of 4-inch pipeline to serve a new grain drying facility. The deviated rate will allow NorthWestern to fully recover the cost of the upgrade, after which the customer will revert back the Rate 86 tariffed rates. The revised tariff sheet is as follow:

At its regularly scheduled meeting of June 15, 2010, the Commission considered this matter. Commission Staff recommended approval.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL 49-34A, specifically 49-34A-6, 49-34A-8, 49-38A-8.3, 49-34A-10, and 49-34A-11. Further, the Commission finds that NorthWestern's request for approval of a Contract with Deviations and associated tariff sheet, with less than 30 days notice, is just and reasonable and shall be approved for service rendered on or after June 15, 2010. As the Commission's final decision in this matter, it is therefore

ORDERED, that the request seeking approval of a Contract with Deviations is in the public interest and is hereby granted; and it if further

ORDERED, that the above-mentioned tariff is approved with less than 30 days notice and is effective for services rendered on and after June 15, 2010.
