On August 28, 2014, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern). This filing proposes to update Sheet No. 6.2 in Section No. 5 of NorthWestern's natural gas tariff. NorthWestern's tariff provides that the Fuel Retention Percentage is to be updated annually and be effective October 1 each year. NorthWestern also proposes to update the fuel rate for customers with an average daily therm usage greater than 30,000. NorthWestern states that customers who fit this high usage criterion are primarily direct connect customers whose gas system is not subject to the normal losses in a distribution system. NorthWestern seeks an effective date of October 1, 2014.

On September 4, 2014, the Commission electronically transmitted notice of the filing and the intervention deadline of September 19, 2014, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. The revised tariff sheet is as follows:

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, including 49-34A-3, 49-34A-4, 49-34A-6, 49-34A-10 and 49-34A-25, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on September 30, 2014, the Commission considered this matter. Finding the tariff revision to be just and reasonable, the Commission voted unanimously to approve the tariff revision. It is therefore

ORDERED, that NorthWestern's revised tariff as described above is approved effective October 1, 2014.
