On March 23, 2016, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern) requesting approval of a contract with deviations and associated tariff revisions to construct a natural gas line to serve Novita Aurora, LLC (Novita). Novita will be a new customer on NorthWestern's natural gas system near Aurora, South Dakota. Novita is building an ag processing plant and requires natural gas transportation service. Novita will be served under Rate 87 tariff rates with deviations from some of the general terms and conditions within the tariff. The contract with deviations provides for additional protections for NorthWestern and its legacy customers. The revised tariff sheet is as follow:

On March 24, 2016, the Commission electronically transmitted notice of the filing and the intervention deadline of April 8, 2016, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A, specifically 49-34A-6, 49-34A-8, 49-34A-83, 49-34A-10, 49-34A-11, and ARSD 20:10:13:09 and 20:10:13:10.

At its regular meeting on April 27, 2016, the Commission considered this matter. Commission staff recommended approval. Finding that NorthWestern's request for approval of a contract with deviations and the associated tariff sheet is just and reasonable, and in the public interest, the Commission voted unanimously to grant NorthWestern's request for a contract with deviations and approve the associated tariff sheet with an effective date of May 1, 2016. It is therefore

ORDERED, that NorthWestern's request seeking approval of a contract with deviations is hereby granted with an effective date of May 1, 2016. It is further

ORDERED, that the above-referenced tariff sheet to reflect this contract with deviations is approved.
