ORDER APPROVING TARIFF REVISIONS

On August 27, 2018, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern). This filing proposes to update Sheet No. 6.2 in Section No. 5 of NorthWestern's filed natural gas tariff. NorthWestern's tariff provides that the Fuel Retention Percentage is to be updated annually and be effective October 1 each year. NorthWestern also proposes to update the fuel rate for customers with an average daily therm usage greater than 30,000. NorthWestern states that customers who fit this high usage criterion are primarily direct connect customers whose gas system is not subject to the normal losses in a distribution system. NorthWestern seeks an effective date of October 1, 2018. The revised tariff sheets are as follows:

Canceling 22nd Revised Sheet No. 6.2

On August 30, 2018, the Commission electronically transmitted notice of the filing and the intervention deadline of September 14, 2018, to interested entities and persons on the Commission's PUC Weekly Filings electronic listsery. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, including 49-34A-4, 49-34A-6, 49-34A-10, and 49-34A-25, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on September 18, 2018, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an October 1, 2018, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the tariff revisions, effective October 1, 2018. It is therefore

ORDERED, that NorthWestern's request to revise its aforementioned tariff is hereby granted and the revisions are approved, effective October 1, 2018.
