On November 27, 2018, the South Dakota Public Utilities Commission (Commission) received a petition from MidAmerican Energy Company (MidAmerican) for approval of revisions in Section 6 – Sample Forms to reflect a revised bill design to the Standard Residential Bill Form. The company requests an effective date of December 31, 2018 for the proposed tariff revisions.

On November 29, 2018, the Commission electronically transmitted notice of the filing and the intervention deadline of December 10, 2018, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, including 49-34A-4 and 49-34A-10 and ARSD 20:10:13:12 and 20:10:17:03.

At its regularly scheduled meeting on December 28, 2018, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an December 31, 2018, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the tariff revisions, effective December 31, 2018. It is therefore

ORDERED, that MidAmerican's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective December 31, 2018.
