On March 27, 1997, the Public Utilities Commission (Commission), in accordance with SDCL 49-31-3 and ARSD 20:10:24:02, received an application for a certificate of authority from RSL COM U.S.A., Inc. (RSL).

RSL proposes to offer four types of service: presubscribed direct dial interexchange service; inbound WATS; directory assistance; and prepaid card service. A proposed tariff was filed by RSL. The Commission has classified long distance service as fully competitive.

On March 27, 1997, the Commission electronically transmitted notice of the filing and the intervention deadline of April 11, 1997, to interested individuals and entities. No petitions to intervene or comments were filed and at its regularly scheduled October 28, 1997, meeting, the Commission considered RSL's request for a certificate of authority. Commission Staff recommended granting a certificate of authority, subject to the condition that RSL not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission.

The Commission finds that it has jurisdiction over this matter pursuant to Chapter 49-31, specifically 49-31-3 and ARSD 20:10:24:02 and 20:10:24:03. The Commission finds that RSL has met the legal requirements established for the granting of a certificate of authority. RSL has, in accordance with SDCL 49-31-3, demonstrated sufficient technical, financial and managerial capabilities to offer telecommunications services in South Dakota. The Commission approves RSL's application for a certificate of authority, subject to the condition that RSL not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission. As the Commission's final decision in this matter, it is therefore

**ORDERED**, that RSL's application for a certificate of authority is hereby granted, subject to the condition that RSL not offer a prepaid calling card or require deposits or advance payments without prior approval of the Commission. It is

**FURTHER ORDERED**, that RSL shall file informational copies of tariff changes with the Commission as the changes occur.
