On April 17, 1997, the Public Utilities Commission (Commission), in accordance with SDCL 49-31-3 and ARSD 20:10:24:02, received an application for a certificate of authority from Association Administrators, Inc. (AAI).

AAI intends to offer 1+ direct dialing, 800 toll free, and travel card (no prepaid calling cards) service through the resale of telephone services. A proposed tariff was filed by AAI. The Commission has classified long distance service as fully competitive.

On April 17, 1997, the Commission electronically transmitted notice of the filing and the intervention deadline of May 2, 1997, to interested individuals and entities. No petitions to intervene or comments were filed and at its regularly scheduled June 3, 1997, meeting, the Commission considered AAI's request for a certificate of authority. Commission Staff recommended granting a certificate of authority.

The Commission finds that it has jurisdiction over this matter pursuant to Chapter 49-31, specifically 49-31-3 and ARSD 20:10:24:02 and 20:10:24:03. The Commission finds that AAI has met the legal requirements established for the granting of a certificate of authority. AAI has, in accordance with SDCL 49-31-3, demonstrated sufficient technical, financial and managerial capabilities to offer telecommunications services in South Dakota. The Commission approves AAI's application for a certificate of authority. As the Commission's final decision in this matter, it is therefore

ORDERED, that AAI's application for a certificate of authority is hereby granted, effective June 17, 1997. It is

FURTHER ORDERED, that AAI shall file informational copies of tariff changes with the Commission as the changes occur.
