On October 14, 1998, the Public Utilities Commission (Commission), in accordance with SDCL 49-31-3 and ARSD 20:10:24:02, received an application for a certificate of authority from Megsinet-CLEC, Inc. (Megsinet).

Megsinet is a resale common carrier that proposes to offer interexchange direct dialed (1+), inbound toll free and travel card services to customers throughout South Dakota. Intrastate service is offered as an add-on to interstate service. A proposed tariff was filed by Megsinet. The Commission has classified long distance service as fully competitive.

On October 15, 1998, the Commission electronically transmitted notice of the filing and the intervention deadline of October 30, 1998, to interested individuals and entities. No petitions to intervene or comments were filed and at its regularly scheduled November 3, 1998, meeting, the Commission considered Megsinet's request for a certificate of authority. Commission Staff recommended granting a certificate of authority.

The Commission finds that it has jurisdiction over this matter pursuant to Chapter 49-31, specifically 49-31-3 and ARSD 20:10:24:02 and 20:10:24:03. The Commission finds that Megsinet has met the legal requirements established for the granting of a certificate of authority. Megsinet has, in accordance with SDCL 49-31-3, demonstrated sufficient technical, financial and managerial capabilities to offer telecommunications services in South Dakota. The Commission approves Megsinet's application for a certificate of authority. As the Commission's final decision in this matter, it is therefore

ORDERED, that Megsinet's application for a certificate of authority is hereby granted, effective December 14, 1998. It is

FURTHER ORDERED, that Megsinet shall file informational copies of tariff changes with the Commission as the changes occur.
