On June 29, 1999, Cheyenne River Sioux Tribe Telephone Authority (CRSTTA) filed for approval by the Public Utilities Commission (Commission) its 1998 Intrastate Switched Access Cost Study. On December 30, 1999, CRSTTA filed its revised Cost Study.

On July 1, 1999, the Commission electronically transmitted notice of the filing and the intervention deadline of July 16, 1999, to interested individuals and entities. On July 13, 1999, the Commission voted to assess a filing fee as requested by the Executive Director up to the statutory limit of \$100,000. Staff filed a memorandum on December 9, 1999, with the concurrence of the company, setting forth a recommended revenue requirement and minutes of use. The Commission considered this matter at its December 28, 1999, meeting. The matter was deferred so that the company could respond to questions raised by the Commission. The company subsequently amended its revenue requirement consistent with the Commission's concerns. The Commission again considered this matter at its January 6, 2000, meeting.

The Commission has jurisdiction over this matter pursuant to SDCL 1-26-17.1, 49-1A-9, 49-31-12.4, 49-31-12.6, 49-31-18, 49-31-19 and ARSD 20:10:01:15.02, 20:10:01:15.05, 20:10:27:07 and 20:10:27:08. Upon review of CRSTTA's filing, the Commission found that the revenue requirement, as amended, and minutes of use were fair and reasonable and should be approved. As the Commission's final decision in this matter, it is therefore

ORDERED that CRSTTA's revenue requirement, as amended, and minutes of use are hereby approved and shall be incorporated in the Local Exchange Carriers Association's determination of switched access rates. (See TC99-067.)
