On February 11, 2005, the South Dakota Public Utilities Commission (Commission) received a filing from McLeodUSA Telecommunications Services, Inc. (McLeodUSA) for approval of revisions to its Access Tariff No. 1. McLeodUSA filed for textual changes to the Application, the Definition and the Regulations Sections of its Access Tariff No. 1.

On February 17, 2005, the Commission electronically transmitted notice of the filing and the intervention deadline of March 4, 2005, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of May 10, 2005, the Commission considered this matter.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. The Commission unanimously voted to approve the above revisions to the Access Tariff No. 1, except the second sentence of Section 2.6.2(G) of Section 2, Original Page 17, which is denied. It is therefore

ORDERED, that the Commission approves the above referenced revisions to the Access Tariff No. 1, except the second sentence of Section 2.6.2(G) of Section 2, Original Page 17, which is denied.
